

# Development Services Building Re-Opens

The Development Services Building (DSB) in the Douglas J. Watson Municipal Complex is once again open for business. Last year, several departments relocated to allow for the renovation of the structure, which served as Auburn City Hall from the late seventies until 2001. Completed renovations allow for a more energy efficient building with an updated work environment, improved customer service areas and improved accessibility in accordance with ADA standards.

The Planning Department, Public Works Department and Public Safety Department - Codes Enforcement Division have all been serving customers from alternate locations during the renovation. In early September, the DSB re-opened for business with these development related offices once again housed together for more convenient "one stop shopping" for the public.

# **Help Prevent Stormwater Pollution**

The City of Auburn operates a municipal separate storm sewer system (MS4) under a Phase II National Pollutant Discharge Elimination System (NPDES) permit issued by the Alabama Department of Environmental Management (ADEM). Under this permit, the City implements a monitoring program to find and eliminate what are known as "illicit discharges." An illicit discharge is any discharge into a storm sewer system or its receiving waterbodies (i.e. streams, lakes, etc...) that is composed of anything other than stormwater. Examples include but are not limited to washing machine "greywater," motor oil, grease, antifreeze, paint thinner, sanitary sewage, industrial wastewater, and sediment runoff from land disturbance. To comply with Phase II requirements the City conducts weekly water quality monitoring and visual inspections at various locations on all of its receiving waterbodies. Additionally, the City investigates all claims of violations of the Illicit Discharge Ordinance and takes appropriate enforcement action as required. Exemptions to this ordinance are: landscape irrigation, springs, water from crawl space pumps, residential car washing, swimming pools, street wash water, and firefighting activities. # **City of Auburn Flood Protection & Preparation Information**

In May 2014, the City of Auburn was accepted into the National Flood Insurance Program's (NFIP) Community Rating System (CRS). Even though everyone does not own or live on property in a floodplain, the program benefits the community by protecting the environment, making people safer, and saving everyone money. The City received a Class 7 score for our CRS application, which allows citizens of Auburn a 15% discount on their flood insurance for those in the Special Flood Hazard Area and a 5% discount for those in the Non-Special Flood Hazard Area. Below is some information you might find helpful regarding floodplains in the City of Auburn.

### **Local Flood Hazard**

The City of Auburn has an annual precipitation of 52.6 inches, with a history of major storm events. Over the last ten years our biggest rain events occurred in May 2003, March 2005, June 2005, November 2006, December 2009, July 2011, and November 2011. During major storm events flash flooding can occur.

## Flood Warning

The City of Auburn, in conjunction with the Lee County Emergency Management Agency, work together to give citizens ample warning in case of a flooding event. Emergency messages are broadcast through local radio stations: 95.9 FM WTGZ, 96.9 FM WQSI, 97.7 FM WKKR, 98.7 FM WANI, 94.3 FM WGZZ, as well as on local television stations: WRBL, WXTX, WTVM, WSFA, and The Weather Channel. In the event of heavy rains, it is essential to monitor television and/or radio weather broadcasts for up-to-date forecasts. Please call 911 for any emergencies and 334-501-3100 for any non-emergencies.

# **Flood Safety**

The following safety tips can keep you and your family from harm:

- Do not walk through flowing waters.
- Do not drive through a flooded area.
- Stay away from power and electrical lines.
- · Shut off all gas and water valves.
- Have a departure plan in case of emergency.

# **Property Protection Measures**

During the past 100 years, flooding has been the number one cause of property damage in North America. There are some permanent retrofitting techniques that can help to eliminate or reduce flood damage:

- Elevating your house 1 ft. above the base flood elevation.
- Flood proofing your house to make the walls and flooring watertight so that water cannot enter.
- If you know you are in a flood prone area, flood vent the crawl space under your home so that water can flow through.

Employees from the Public Works Department are available for site visits to review flooding, drainage and sewage

issues and to provide one-on-one advice to the property owner on appropriate flood protection measures. We are also available to assist in reviewing and critiquing retrofit plans for flood-prone residences and buildings.

### **Are You Insured?**

The City of Auburn is an active participant in the National Flood Insurance Program (NFIP) and plays a leading role in keeping citizens informed regarding the local floodplain and how it can affect their property. Even if your property is not located in a high risk flood area it is a good idea to buy flood insurance, as 25% of all flood insurance claims come from areas with minimal flood risk. Two important facts that citizens should know are:

- Homeowner's insurance policies DO NOT cover flood damages or losses.
- Insurance policies have a 30-day waiting period BEFORE coverage goes into effect.

There are two types of Flood Insurance Coverage offered: 1. Building Property, up to \$250,000, and 2. Personal Property (Contents), up to \$100,000. The NFIP encourages people to purchase both types of coverage. Your mortgage company can also require that you purchase a certain amount of flood insurance.

# Floodplain Development Permit Requirements

To ensure the highest degree of safety, the Public Safety Codes Enforcement Division enforces all adopted building, fire and related codes in the City of Auburn. Please be advised that a permit is required for ALL construction in

If you know of any development taking place without the required permits or would like to verify a contractor's license, please contact the City of Auburn Codes Enforcement Division, located at 171 North Ross Street (Suite 100), at 334-501-3170.

# Substantial Improvement Requirements

In order to participate in the National Flood Insurance Program (NFIP), The City of Auburn has adopted regulations and codes that apply to new developments in floodplains. Local floodplain management regulations and codes contain minimum NFIP requirements that apply not only to new structures, but also to existing structures which are "substantially improved (SI)" or "substantially damaged (SD)."

"Substantially Damaged" means damage of any origin sustained by a structure whereby the cost of restoring the structure to it's pre-damaged condition would equal or exceed 50% of the market value of the structure before damage occurred.

"Substantially Improved" means any reconstruction, rehabilitation, addition, or other improvements of a structure, the cost of which equals or exceeds 50% of the market value of the structure before the "start of construction" of the improvement. This term includes structures which have incurred "substantial damage," regardless of the actual repair work performed.

The City of Auburn requires an elevation of 1 ft. above the base flood elevation for new construction and for existing structures before they are repaired.

# Do You Live In Or Around a Special Flood Hazard Area?

The City of Auburn Public Works Department is available to assist in providing more information on whether a property is in a Special Flood Hazard Area. Upon request, the following Flood Insurance Rate Map (FIRM) information will be provided: The community number, the map panel number and suffix, the date of the FIRM's Index, the Base Flood Elevation (BFE) shown on the FIRM, the elevation datum used on the FIRM, and the availability of Elevation Certificates (EC's) for review. For more general information, you can view your property in relation to the local floodplains online using the City's interactive mapping system at http://www.auburnalabama.org/maps.

# **Drainage System Maintenance**

The City of Auburn's Public Works Department maintains the storm drainage system, helping to keep the creeks and streams in the City of Auburn clean and free of debris and pollutants. Debris, including leaves and grass clippings, can obstruct the flow of water and cause overflow onto streets and yards. In order for the drainage system to operate efficiently, ditches, streams, and channels must be kept clean. Residents and business and property owners can help keep the storm system clean by maintaining ditches and streams on their property and by notifying the City when maintenance is needed in the right of way. The City Code prohibits taking any action that can impede the flow of water in ditches and waterways. If you know of any illegal dumping of debris

or any action that could affect the drainage system, please contact the Public Works Department at 334-501-3000.

# Natural and Beneficial Functions of The Local Floodplain

Floodplain areas and wetlands provide a wide range of benefits to both human and natural systems. The City of Auburn is home to several identified, undeveloped floodplain areas. Wetlands in and around the City of Auburn are a valuable asset.

Flood control is one of the most important aspects of wetlands. Wetlands absorb water during heavy rainfall or flooding and slowly release the waters downstream reducing flood damage.

Water quality is another key aspect of wetlands. Wetlands and wetland plants help to absorb and filter potentially harmful chemicals and pollutants from our waterways.

Our Wetlands are VITAL for several endangered or threatened species unique to this area. Recreation, education, and research of wetlands are critical to our local economy.
